Derek Durst, Public Facilities Manager, presented two quotes for replanting and adding additional plants to the two roundabouts on New Town Road. Mr. Durst and the Board discussed the quotes in depth. The Board asked for clarification on the number and size of the quoted boxwoods, the color of the lantanas, as well as some of the proposed charges for clean-up, recycling, and supply pickup. Mr. Durst will work on getting the quote revised with the Board's feedback.

### 1. Discussion of 2022 Marvin Day Event Planning (Events, Budget, Communications, etc.)

Chairman Baresich informed the Board that he has made progress on securing the parking lot and stadium at Marvin Ridge High for Marvin Day. He stated that staff has been working on the rental paperwork. Vice-Chair Culp has been working on the event logo and will get another logo based on a horse. She informed the Board that Bob Nunnenkamp has been lining up artists and gardeners up for the art and gardens tours. Mayor Pro Tem Vandenberg stated that she spoke with the Raptor Center about participating in Marvin Day. She stated that they plan to set up a booth at the park with games and information. They also plan to conduct a 45-minute program in the barn with birds. They may release a rehabilitated bird if any birds are ready for release. The Board discussed the allocation of duties, the use of event spaces and parking, the event budget, and food trucks in depth.

### **TIME STAMP 50:10**

# 1. Update on Future Trails

### a. Tullamore Phase 3 & Connector to Rea Rd Commercial

Hunter Nestor, Planning & Zoning Administrator, informed the Board that Council pushed back the Tullamore Phase 3 Trail. The Board discussed the possible donation of land from Pulte Homes near the Towns at Ardrey development for park land, as well as the securement of an easement to connect the Tullamore/Amber Meadows Trails to the commercial corridor on Rea Road.

#### b. Preserve Trail & Innisbrook Connector

Mr. Nestor stated that he and Mr. Durst will be working on an RFP for the Preserve Trail soon. Council has funded the trail in this year's budget. Mr. Nestor reflected on his previous discussion with Innisbrook residents who were interested in providing a trail easement to connect Innisbrook to the Preserve Trail. He stated that discussions are ongoing and that he will provide an update when he has more information.

#### c. Belle Grove Trail

Mr. Nestor stated that the Belle Grove community is not in favor of the construction of this trail due to privacy concerns. He informed the Board that Council directed him to ask the developer to provide a fee-in-lieu instead of building the trail. He stated he was also directed to ensure that the Village retains the trail easement.

#### d. Roundabout-Marvin Road Sidewalks

Mr. Wilson asked staff where NCDOT and the Village stand with the construction of sidewalks along Marvin Road in relation to the construction of the roundabout at New Town and Marvin Road. Staff will consult with NCDOT.

- Mr. Nestor will send the Village Hall plans with trail easements to Mr. Wilson.
