VILLAGE COUNCIL SPECIAL MEETING MINUTES

Friday, November 19, 2021 – 11am Village Hall, 10004 New Town Road Special Meeting (Virtual Meeting)

SPECIAL MEETING AGENDA

Mayor Pollino has called for a special meeting of the Village Council to be held on Friday, November 19, 2021 at 11am at Village Hall (10004 New Town Rd) in order for Council recess into Closed Session pursuant to NCGS §143-318.11(a)(3) to consult with an attorney employed or retained by the public body in order to protect the attorney-client privilege; to discuss terms for solid waste services; to discuss and consider a contract for underbrush removal at the site of the new Marvin Village Hall and the Marvin Gardens-area pocket park, and to consider adoption of a budget amendment.

1. Call to Order & Determination of Quorum

Mayor Pro Tem Vandenberg called the meeting to order at 11:03am and determined a quorum was present.

2. Consider Allowing Councilmembers to Participate Remotely

MOTION: Councilman Wortman moved to allow Councilmembers to participate remotely.

VOTE: The motion passed unanimously, 4-0.

3. Adoption of the Agenda

MOTION: Councilman Wortman moved to adopt the agenda as presented.

VOTE: The motion passed unanimously, 4-0.

4. Recess into Closed Session pursuant to NCGS §143-318.11(a)(3) to Consult with an Attorney Employed or Retained by the Public Body in Order to Protect the Attorney-Client Privilege

Mayor Pollino arrived at 11:06am.

5. Discussion of Solid Waste Services including Contract Terms

Christina Amos, Village Manager, introduced the attendees from Active Waste Solutions and asked them to clarify their requests with changes to the fines and fees in the proposed solid waste services contract. The representatives requested changes to improve parity regarding a clause that would allow the Village to exit the contract for any reason. Active Waste Representatives and the Village Council discussed customer service standards, liquidated damages, and general requirements.

6. Discuss and Consider Waiving the Three-Bid Requirement AND Consider Options for Brush Clearing Village Hall Site and Marvin Gardens-area Pocket Park in an Amount TBD (See attached, Item 6., which is included as a reference in these minutes). Austin W. Yow, Village Clerk and Assistant to the Manager, explained that three quotes were not received for the brush clearing. Council discussed the quotes, as well as in-house alternatives in depth. Council by consensus agreed to complete the brush clearing at the new Village Hall in-house. Council also agreed to move forward with the brush clearing with the pocket park at the price provided.

MOTION: Mayor Pro Tem Vandenberg moved to approve the \$6,000 pocket park situation and to waive the three-bid requirement.

VOTE: The motion passed unanimously, 4-0.
