Chairman Baresich called the meeting to order at 9:03am.

**3. Adoption of the Agenda**

**MOTION:** Vice-Chair Culp moved to switch items #1 and #3. Dan Wilson seconded the motion.

**VOTE:** The motion passed unanimously, 3-0.

**4. Adoption of the Minutes: 6/1/21**

**MOTION:** Vice-Chair Culp moved to adopt the minutes from 6/1/21 as written. Dan Wilson seconded the motion.

**VOTE:** The motion passed unanimously, 3-0.

**TIME STAMP 2:10**

Vice-Chair Culp highlighted recent volunteer efforts of more than 50 hours at Marvin Efird Park. Dan Wilson discussed recent flooding at the Cottage Garden at Marvin Efird Park.

**TIME STAMP 5:45**

**1. Discussion of National Night Out 2021**

Deputy Montgomery described some of the events including an SRT Vehicle, a K9 Unit demonstration, Animal Services, EMS, Fire Department, Highway Patrol, etc. He then discussed donations from local businesses.

**2. Discussion and Consideration of Roundabout Plants**

Vice-Chair Culp described a proposal for the roundabout plants drafted by Mr. Nunnenkamp, which includes Wintergreen Boxwoods, native plants, Muhly Grass, annuals/perennials, and Hollies. The Board discussed the proposal and agreed to keep the existing proposal, and get quotes for replacing the dead redbud, as well as adding lantana and wintergreen boxwoods.

**3. Discussion of 2022 Marvin Day Event Planning**

Chairman Baresich stated he has been talking with residents to host equestrian events for Marvin Day. Mr. Durst stated he has received tentative approval to use Marvin Elementary School's parking lot for events. The Board discussed hosting a run, possibly a 5K run, as well as trail tours. Mayor Pro Tem Vandenberg gave an update on Firethorne's interest in participating in Marvin Day.

**MOTION:** Vice-Chair Culp moved to excuse Mr. Wilson from the meeting. Dan Wilson seconded the motion.  
**VOTE:** The motion passed unanimously, 3-0.

A quorum was lost, no further action was taken. Board members then discussed musical acts and sponsorships.

No comments were given.


**ADJOURNMENT**
