## **RULES & GUIDELINES**

1. Gardens shall open and close with park hours.
2. Each gardener is responsible for the maintenance and upkeep of their garden plot and surrounding pathways. Watering, weeding, harvesting and any other garden related maintenance are all the responsibilities of the gardener. Gardeners may harvest vegetables and flowers from their garden only.
3. If any plot is unattended for more than three weeks, a representative of Habitat Builders will contact the responsible party and has the ability to reassign or till the plot.
4. A limited number of tools, hoses and watering equipment will be available in the community garden storage shed for gardeners use. Power tools are prohibited.
5. Plastic mulches are prohibited due to problems associated with clearing plots in the fall.
6. Place all organic waste in designated compost areas only.
7. Fertilizers, insecticides and dust may be used only in such a way as to not affect adjacent gardens and grassed areas. Preen, Round-Up, and like herbicides are prohibited.
8. At the end of the growing season, gardeners are responsible for clearing their plot of all plant material and leaving the plot as they found it in the spring.
9. Children are welcome in the garden but must be accompanied by an adult and must be supervised at all times. Pets are not allowed in the garden area.
10. Illegal or poisonous plants are prohibited.
11. The Village of Marvin AND Habitat Builders cannot guarantee protection against vandalism or theft. Any thefts or vandalism should be reported to the Village.
12. RELEASE, ACQUIT, AND FOREVER DISCHARGE the Village AND Habitat Builders from any and all claims, losses, damages, or liability (present or future) on account to any injury to persons or property, including injury resulting in death, arising out of or in any way connected with the use of the Property for the Activity specified above.
