**RESOLUTION IN APPRECIATION OF BOB NUNNENKAMP'S SERVICE TO THE MARVIN COMMUNITY**

**WHEREAS** the Village of Marvin desires to recognize and honor board members of the Village for dedicated and distinguished contributions to the community; and

**WHEREAS** Bob Nunnenkamp was appointed to serve on the Parks, Recreation, and Greenways Board on Tuesday, February 13, 2018, by a unanimous vote of the Village Council; and

**WHEREAS** Bob Nunnenkamp was subsequently reappointed to continue to serve on the Parks, Recreation, and Greenways Board in 2018 and 2021, also by unanimous votes of the Village Council; and

**WHEREAS** in the course of his service on the Parks, Recreation, and Greenways Board, Mr. Nunnenkamp continually provided expertise on wildlife and plant life; and

**WHEREAS** Mr. Nunnenkamp established MARSH, the Marvin Area for the Restoration and Sustainability of wildlife Habitats, a local chapter of the North Carolina Wildlife Federation serving the 28173-zip code, in 2019; and

**WHEREAS** Mr. Nunnenkamp worked with MARSH to register the Village of Marvin as a Community Wildlife Habitat in 2019; and

**WHEREAS** Mr. Nunnenkamp served on the Website Committee in 2020 that led to the creation of MarvinNC.gov, a modern website aimed at providing residents greater transparency in their local government; and

**WHEREAS** Mr. Nunnenkamp served on the Wayfinding & Branding Committee in 2022 and 2023, which led to the adoption of new logos and a new seal, the "Enriched by Nature" tagline, and a master plan for future wayfinding signage; and

**WHEREAS** Mr. Nunnenkamp established the "Friendship Tree" in 2022, a partnership of the Village of Marvin and MARSH that has since provided more than one-hundred needy children in Union County with gifts on Christmas morning; and

**WHEREAS** Mr. Nunnenkamp has demonstrated continually that he is a person of immense character, dedicating his time to serving his community, as well as always supporting the Village Staff and the concept of public service; and

**WHEREAS** Mr. Nunnenkamp resigned his position on the Parks, Recreation, and Greenways Board on Tuesday, July 9, 2024.

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the Village of Marvin, that appreciation be shown to Bob Nunnenkamp in honor of his continued service and dedication to the residents of the Village of Marvin. While the Council and Staff are saddened to lose Mr. Nunnenkamp, the Council and Staff wish him the best in his future endeavors. The Council and Staff encourage residents to thank Mr. Nunnenkamp for his service to the Marvin Community.
