2. *To consider the Preliminary Plat and Construction Plan of the Gates at Marvin Rural Subdivision*
3. *To consider the zoning designation of recently-annexed parcel 06210007A, 8802 Bonds Grove Church Road*
4. *To consider the zoning designation of recently-annexed parcel 06207005C, Marvin Efird Park*
